

TERMS AND CONDITIONS

1. The rates are to be quoted clearly in figures as well as in words on flat percentage basis AT-PAR/Above the Schedule of Rate for Meghalaya PWD (Buildings) for the year 2021- 2022.
2. The tenderers should clearly mention their full address with Registration No.
3. The tenderes should submit required 1% for ST & 2% for Non-Tribals Earnest money deposit in the form of DD/Call Deposit/FDR/BG duly pledge in favour of Director, Urban Affairs, Shillong from any recognized bank, payable at Shillong, the tenders without which will not be accepted. The Earnest Money deposited will be refunded/released to the successful/unsuccessful tenderers. (No Earnest Money in the form of cheque will be accepted).
4. Each tender should affix required Court Fee Stamp of without which the tender will not be considered.
5. Name and particulars of the work should be clearly superscribed on the sealed envelope.
6. All non-Tribal tenderer will have to submit a valid trading licenses from the competent Authority without which the tender will not be considered.
7. The undersigned/Deptt will not supply any stock materials or tools and plants to the contractor for execution of the work.
8. Any item of works not mentioned under prescribed Schedule of rates will be finalized as or the approved analysis of rate fixed by the Govt. of the Department.
9. Forest Royalty will be deducted from the bill according to the actual utilization of stone, sand at the rate fixed by the Govt. from time to time.
10. Meghalaya Finance Tax and Income Tax will be deducted from the contractors bill as per Rules.
11. Tenderers are advised to see the site of the construction before dropping tender.
12. Detailed plans and drawings may be seen in the office of the undersigned during office hours in all working days.
13. The undersigned reserves the right to reject any or all tenders without assigning any reasons thereof and does not bind himself to accept or recommend acceptance of the lowest tender.
14. The other Terms and conditions will be as laid down in PWD F-2 form for Tender Agreement to be executed with successful bidders.
15. GST will be deducted as per the work contract of current prevailing rate levied by the Govt. from time to time will be recovered from the Bill.
16. Contractors should sign the Tender Agreement before issuing the Work Order and to submit the attested Pan Card along with the Tender Agreement.
17. In case last date of opening of the tender happen to be a holiday the tender will be opened on the next working day at the same time and hour.
18. Contractors are strictly prohibited of employment of children below 14 years in the work site.
19. 1% Labour Cess shall be deducted from each running & final bill.
20. Contractors are required to register themselves with the Welfare Board otherwise they cannot employ any Construction workers. The registration and fee for employer is to be made against specific work.
21. To register the Labourers with the Meghalaya Building and other Construction Worker's Welfare Board.
22. Contractors are to ensure that their employees/mistri are having bank accounts in order to facilitate financial inclusion of workers and to ensure timely payment of wages.

23. Control measures for fugitive emissions for material handling, conveying and screening operations through water sprinkling, curtains, barriers and dust suppression units shall be employed at the site by the Contractor.
24. Ensure carriage of construction materials in close/covered vessels.
